Privacy

For us, the protection of your personal privacy is important. We treat your personal data confidentially and in accordance with both the data protection legislation and this data protection declaration. By using our website you agree to the collection, processing and use of data in line with the description below.

Our website can, on principle, be visited without prior registration. Data relating to e.g. the pages and sites you call up or to the files you access with date and time are stored on the server for statistical purposes without such data being directly linked to you personally. Cookies

This website uses so-called "cookies". They help to make our services user-friendlier, more effective and more personalised. Server log files

Our web servers automatically collect and save information in so-called server log files, which your browser automatically sends to us. These are:

- Browser type and browser version
- Operating system

- Referrer URL

Collection and processing of personal data

Contact form

If you use our contact form to make an inquiry, the data from this form, including the contact data given by you, are stored here in order to be able to deal with your inquiry and any follow-up questions. We do not pass on this information to anyone else without your approval.

Personal data for e-mail newsletters

If you wish to receive our e-mail newsletter, we need from you an e-mail address and information that will enable us to check that you are the owner of the given e-mail address and that you are in agreement with receiving the newsletter. Providing additional data is purely voluntary. We use all the data exclusively for sending the requested information and do not pass it on to third parties.

You can at any time revoke your consent to use the data for the newsletter, e.g. via the unsubscribe link in the newsletter.

Links

Our Internet sites may contain links to other providers to which our data protection regulations do not apply.

Google Analytics

This website uses Google Analytics, a web analysis service of Google Inc. ("Google"). Google Analytics uses so-called "cookies", which are text files stored on your computer that enable your usage of the website to

be analysed. The information generated by the cookie on your usage of this website is normally transmitted to a Google server in the USA and stored there. Chat function

For the chat function on this site, not only is your comment saved but also the time of the comment was written, your e-mail address, your first and second names and the subscription number.

Our chat function saves the IP addresses of the users who write comments. Since we do not check comments on our site before releasing them, we need these data in order to be able to take legal action against the originator in the event of legal violations such as insult or propaganda.

SSL encryption
